**VOTE ★ MARCH 3**

On **March 3, 2026**, USD 107 Rock Hill voters will consider **TWO** bond questions to address critical facility needs across the district.

**Q1 Bond Question #1** (\$5.67M) focuses on **replacing the HVAC system at the Jr/Sr High School**, consistent with what was included in the previous bond proposal.

Updating this aging system remains a priority to ensure a safe, healthy, and efficient learning environment for students and staff. The projected cost for this work is **\$5.67 million**.

**Q2 Bond Question #2** (Additional \$1.5M, which can only pass if Question #1 passes) addresses the construction of **new secure entrance additions at both district buildings**, in addition to the HVAC project, at a projected cost of **\$1.5 million**.

These proposed entrances are designed to improve traffic flow and ensure that all visitors enter through the main office before being granted access to the school. Creating these new entrances will also allow the current office areas in both buildings to be remodeled into much-needed learning spaces, providing greater flexibility and addressing space needs across the district.

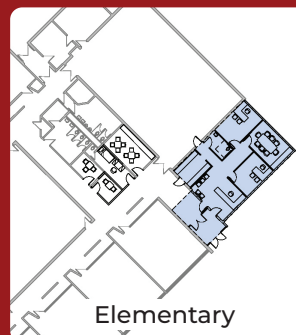

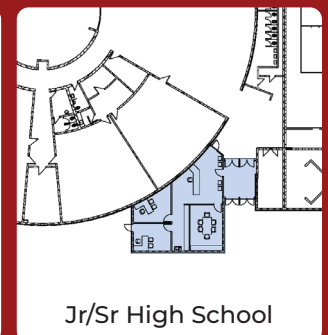

- Provide a single, controlled point of entry during the school day
- Improve student, staff, and visitor safety
- Allow staff to verify and monitor all visitors before granting access
- Reduce the risk of unauthorized entry into school buildings
- Enhance emergency response and lockdown procedures
- Align school facilities with current safety standards and best practices
- Creates a safer, more welcoming entrance for families and community members
- Supports consistent safety procedures across all district buildings

## **Why is the HVAC needed?**

For several years, the district has worked with the community to assess facility needs. The most consistent and significant feedback has been the need for updated, efficient, and reliable school facilities.



A facilities study confirmed that critical systems at the Jr/Sr High School, specifically the HVAC and piping, are failing. At 57 years old, these systems are well beyond their expected lifespan. Despite careful maintenance, they can no longer be repaired in a cost-effective way. Temporary fixes are keeping the building operational, but a full HVAC failure could disrupt school operations, potentially forcing closures.



Replacing these systems exceeds what the district's regular budget can handle. The proposed bond would fund a modern, efficient HVAC system designed for easier maintenance, lower long-term costs, and greater reliability. The district has managed its finances responsibly. The existing system lasted more than 10-15 years beyond its expected life, and must now be replaced.



At this point, continued patchwork repairs are no longer practical. This bond provides a responsible, long-term solution to protect students, maintain safe schools, and support learning for years to come.
